About the Theological Education Scholarship Fund

Scholarship funds are provided to individuals pursuing a formal course of study leading toward a church vocation through a seminary, ministry degree program, or lay pastor education curriculum. They may also be used for CPE, internships, contextual education, or travel to study abroad that is connected to the degree or certificate program. Scholarship candidates will be under care of the Presbytery or pursuing their course of study in direct conversation with the Committee on Preparation or in consultation with a particular congregation for service. Scholarships up to \$2,000 are considered based upon the determined financial need of the individual and the availability of scholarship funds. Generally, each candidate is eligible for one scholarship per academic period and no more than twice per calendar year. Scholarships will not exceed the cost of tuition, fees, books and supplies and other actual costs incurred. Scholarship Funds are made available thanks to the legacy of the Carl Bossman Scholarship Fund, the Dorothy & Ralph Erlandson Fund, and the Barbara Tilton Memorial Scholarship Fund.
